## 1- OBSERVATION / CONTEXT

- Reminder following intelligence reports B7890\_IRRA004\_UNRE and B7890\_IRRA006\_UNRE:
  - May 2014, a Raven unit found out the existence of a large-scale project within 5 years, intending to implement particularly impactful liberticidal measures, legitimised by a context requiring extremely strict security measures, thus forcing public acceptance.
    - The aim of the project, discovered by the Raven unit, is to considerably strengthen population control by radically restricting individual and collective freedoms.
      - Lobbying in government structures are planned in order to take action at legislative & executive levels.
  - Nov 2014 - CONFIDENTIALITY REPORT LEVEL 5 B7890\_IRRA004\_UNRE:
    - Evidence obtained about the project's scope: the entire world population is targeted.

## 2- OBJECTIVES

- Appoint an elite Fox unit, trained specifically for this mission, to lobby various European Union structures.
  - The ultimate goal is to prevent excessive liberticidal laws at European level, since the impact would be detrimental to our strategy.
  - The Fox unit has to remain in position until the end of the pandemic.

## 3- ACTIONS

- Apr 2019:
  - Launch of the Fox unit's training.
- From Oct 2019:
  - Identification of lobbying targets by the Raven unit infiltrated in the various European Union structures.
  - Design of lobbying strategies by a Wolf unit, reconciling our goals with the interests of the members of the European Council, within legal boundaries (report B7890\_IRRA012\_PLST).
  - Identification of lobbyists working for the project's instigators by the Raven unit.
  - Several strategies have been designed by a Wolf unit, in order to block their actions (report B7890\_IRRA013\_PLST).
  - Fox unit applied successfully all the details contained in the strategy documents.
  - Allow European countries to adopt liberticidal laws within the limits defined in the strategic plan (report B7890\_IRRA012\_PLST), in order to contrast with the European Union's position regarding the pandemic.

#### 4- RESULTS

- Endorsement of limited liberticidal measures by the European Parliament, as described in report B7890\_IRRA012\_PLST.
  - In accordance with the instructions given, it clearly states that in the event of force majeure European countries are allowed to take critical measures, which may reduce individual freedoms if necessary.
- Final observations based on reports from the Raven units:
  - In accordance with the action plan: discredit of countries that have made vaccination mandatory since the European Parliament has not taken a clear position on this subject.
  - Self-contradiction of the European Parliament through its failure to adopt measures related to mandatory vaccination, despite a prior vote on restrictive laws.
    - Misunderstanding among parts of the population, who do not understand why the European Union did not follow through with its process.
    - Discredit of European governments and institutions through the aforementioned lack of understanding.
      - Underline the clear incompetence at managing the pandemic.
    - According to our strategic plan: awareness of the populations about the futility of such measures, in observation of a significant decline in the damage caused by the pandemic.
      - Note that vaccination is no longer a risk since the substitution of BNT162-bXXX vaccines by YMG837-yXXX vaccines (see report B7890\_IRRA011\_ACCO). The problem is about fundamental human rights and freedoms.
  - Total success of the operation: targeted outcome achieved.
